

Call for DOHaD Canada President-Elect and Council Nominations

We are currently seeking DOHaD Canada members who would like to play an active role in influencing the direction of our Society. DOHaD Canada is managed by DOHaD Canada Council, a standing body of representatives of the Canadian DOHaD Community. This cycle up to **10 Councillors** are being sought through election.

Deadline for nominations is December 3, 2021.

Council members are drawn from all regions of Canada, and specialties (basic sciences, clinical sciences, population research and public health). There are 2 'in training' members of Council. Current Council members are listed below. The Council 'meets' by teleconference 6-8 times a year, and in person at each Annual meeting (when possible). Leadership of the Council is made up of a President, a Secretary and a Treasurer and this body (Executive) 'meets' by teleconference 8-10 times a year and in person at each Annual meeting.

Qualifications for joining **Council** are DOHaD Canada membership (at the Faculty-Level), a desire to have a say, and willingness to participate in developing the Society's strengths and activities. We welcome people at all faculty career levels and strive for diversity. Each member of Council serves for three (3)* years and can serve up to two consecutive terms. Any DOHaD Canada member can nominate themselves for the Council election, or nominate another member, but please check with them first; we will need an e-mail from the individual stating that they are willing to stand. Nominees must be DOHaD Canada members in good standing and actively engaging in DOHaD-Canada type research/activities. DOHaD Canada Council members must be members of DOHaD International.

We are also calling for nomination of **DOHaD Canada President-Elect**. This individual will become a member of the Executive and will serve for a year as President-Elect beginning at the 2022 AGM. They will take office as President at the 2023 DOHaD AGM. Nominations for DOHaD Canada Executive positions require previous membership of DOHaD Canada Council. Nominees must be current or former DOHaD Canada Council members in good standing and actively engaging in DOHaD-Canada type research/activities. The DOHaD Canada President-Elect must be a member of DOHaD International.

All nominations must include a cover letter (max 1 page) explaining why the nominee is a good candidate for the position and a SHORT (1 page) brief CV highlighting roles and responsibilities that make the nominee suitable for the position. The Cover letter and CV will be distributed to the membership for review prior to voting. In addition, the nominee must provide e-mail confirmation that they are willing to be nominated.
